
Report on Special Lecture in Government Higher Secondary School, Kanota (CT)
Bassi Jaipur by UBA Team, The ICFAI University, Jaipur- - Under UBA Scheme

On 19th May 2023, Dr. Pratima Soni (Assistant Professor, ICFAI Law School, and UBA Project Coordinator) along with Mr. Ashish Acharya (Faculty In-charge- Legal Aid & Pro Bono Committee, ILS) visited Government Sr. Sec. School, Kanota(CT) Village which will be adopted by The ICFAI University, Jaipur under 'Unnat Bharat Abhiyan' Scheme (hereinafter referred as UBA). For the same, the team departed from the University at 10:15 A.M.

The aim of this visit was to acquaint us with the present situation of the school system of the village and important issues related to the literacy of the village which can be covered in the UBA Scheme and under the Legal Aid Cell of the ICFAI University, Jaipur. This visit was successfully accompanied by the Special Lecture by Dr. Pratima Soni, Associate Dean –ILS, Jaipur and UBA Project Coordinator on UBA Scheme including the importance of education, hygiene, Child-Labour and other Legal Provisions especially in reference to the Children’s Rights and Justice System related to the treatment of Juveniles. She also discussed not to afraid of Police Officers and held that “they are for your safety and not to harm you.” The next Lecture was delivered by Mr.Ashish Acharya, Assistant Professor-ILS & Faculty-in-charge of the Legal-Aid and Pro-Bono Committee of the ICAFI University, Jaipur. In this lecture he discussed Fundamental Rights, Fundamental Duties along with the general scheme of the Indian Constitution in reference to Children and women. The whole discussion under both of the lectures was operated with the use of appropriate PPT and with some prominent suitable real-life examples. The school staff was quite cooperative which an act of appreciation for their side is also.

In pursuant to the same, we met Mr. Bhavani Singh Rajawat, Principal of the school (mentioned in the subject). While discussing the relevant information in respect to UBA, we noted some important particulars which are necessary to get them updated on UBA and for our consideration also. We have also observed the atmosphere of the school and have planned to frame some suitable activities which will be beneficial for both the students of the school and as well as the learners of the ICFAI University, Jaipur.
