Objectives of the Survey and Visit

1. To assess the level of awareness of basic human rights among village residents

This objective focuses on understanding whether people know about fundamental rights such as the right to equality, education, health, livelihood, and protection from discrimination and exploitation.

2. To identify common human rights issues and violations faced by villagers in daily life

The survey aims to document problems such as domestic violence, child labour, caste-based discrimination, denial of wages, access to government schemes, and issues related to women, children, and elderly persons.

3. To examine access to justice and awareness of legal remedies and government welfare schemes

This objective seeks to understand whether villagers know where to seek help such as legal aid services, police, courts, Panchayats, or NGOs and whether government schemes meant for their welfare are actually reaching them.

4. To recommend measures for strengthening human rights protection at the village level

Based on survey findings, this objective aims to suggest legal awareness programs, legal aid camps, policy interventions, and community participation to improve the protection and realization of human rights.

Transaction of Event

The Centre for Human Rights and Gender Justice, ICFAI Law School performed a door to door survey and human rights awareness campaign after receiving recommendations and suggestions by Hon'ble President Sir, Prof Dr H P Singh VSM Sir and time to time guidance by Advisor of the Centre, Dr Harish Kumar Verma Sir, Dean, ICFAI Law School, Jaipur. There were total of 52 students from B.A.LL. B-IV Semester involved in this activity along with 2 student members from Centre itself. Mr. Ratnesh Pandey and Mr. Ashish Acharya were assigned to accommodate students for guiding this survey and reached with survey team to Sumel Village at 12:00 Noon and completed survey at 1:30 P.M. and back to the campus by 1:50 P.M.

Outcomes of the Activity:

- Created mass awareness about the legal and social implications of instances of Human Rights Violations.
- Performed Survey on different age groups people from children to senior citizens.
- Enhanced student involvement in community-oriented Human Rights education.
- Promoted the basic human rights by reaching door to door among village homes.
