(A) Poster Making Competition: -

6. **Engagement with Community Issues** – To highlight local, national, and global human rights concerns relevant to society and legal education.
7. **Student Participation and Teamwork** – To encourage active participation, collaboration, and healthy competition among law students in an interactive and engaging format.
8. **Promoting Human Rights Education** – To reinforce the significance of human rights in legal education and practice, aligning with the mission of the Human Rights Centre.

(B) Essay Writing Competition

1. **Promoting Legal Research & Writing Skills** – To enhance students’ ability to research, analyse, and present arguments effectively on contemporary human rights issues.
2. **Deepening Human Rights Understanding** – To provide an opportunity for students to explore the theoretical and practical dimensions of human rights in national and international contexts.
3. **Encouraging Critical & Comparative Analysis** – To stimulate critical thinking on legal, social, and policy-oriented aspects of human rights, including comparative perspectives from other jurisdictions.
4. **Developing Advocacy through Writing** – To cultivate persuasive writing skills that are essential for human rights advocacy, litigation, and policy drafting.
5. **Engagement with Current Challenges** – To encourage law students to reflect upon pressing human rights concerns such as gender justice, minority rights, refugee rights, digital privacy, climate justice, etc.
6. **Promoting Academic Excellence** – To provide a platform for students to contribute original insights that can enrich academic discourse and policy debates on human rights.
7. **Recognition of Student Talent** – To recognize and reward meritorious contributions, motivating students to pursue deeper engagement with human rights law.
8. **Linking Classroom Knowledge with Practice** – To connect theoretical understanding from the classroom with real-world challenges faced in human rights protection and enforcement.

Detailed Report: The Centre for Human Rights and Gender Justice at ICFAI Law School, Jaipur organized two major student-centric events on 27th August, 2025 Poster-Making Competition and an Essay Writing Competition to mark its commitment towards promoting human rights awareness, creativity, and academic excellence among budding law professionals.
