OPTIMISTIC VISION OF Judicial Activism

"Justice is supreme and justice ought to be beneficial for the Society so that the society is placed in better-off situation. Law courts exist for the society to rise up the occasion to do Needful in the matter, and as such may sub-serve the Basic requirement of the society. It is a requirement of the Society and the law has to respond to its need."

The phrase- Judicial Activism is a philosophical ideology in legal world which is holding that the bench or judges go beyond the applicable law for the protection of fundamental rights described by the Constitution of India, 1949 and also to deliver justice to the citizens of any civilization."

India being a quasi-federal nation where the three tier system is observed and in this system all three bodies have their own authorities and responsibilities but in certain scenario when two bodies i.e. executive and legislature fails to accomplish the goal of constitution which is to furnish justice and form laws in public interest than judiciary enlightens the path and fills the gap.

In recent developing and dynamic era, it has become a very vibrant issue in Indian judicial system.

It has become imperative to understand the clear meaning and the purpose of the approach. Judicial Activism had played a cardinal role in protecting public interest, be it in the case of protecting the working women from sexual harassment or be it a case of bounded labour, Hon'ble Court has taken stands for protecting of human rights or be it a fundamental rights which are provided by the Constitution of India. Massive number of cases are the witness where there is requirement of interpretation of laws or absence of any laws in that prevailing situation and in these cases judiciary cannot sit idle, it the duty of judiciary to accomplish justice and need to be more activist in nature and here the new revolution of judicial activism emerges.

The phenomenon is an activist move when a court make a shift from its traditional role of delivering natural justice and starts performing the role of legislation and make new laws, new rules. India has an emerging history of judicial activism. Though its origin can be trace back in the year 1893, when Justice Mahmood of Allahabad High Court has sowed the seeds of judicial activism in the period of emergency. Imposing emergency was an attempt of government to control judiciary. Therefore, to avoid injustice judges crosses the strict barriers of applicable laws made by legislation to illuminate the citizens with the glory of justice and also go beyond the borders of separation of powers. Nowadays judges have been burdened with heavy responsibility to evolve law in consonance with the dynamic needs and aspirations of the society and to serve the cause of social justice, therefore judicial activism is the sown seed of this approach.

The scope of judicial activism not limited to only a single perspective, it is used to look in the matters and enforce what is beneficial for the society at large. The word "JUSTICE" has no finish lines, it is a critical approach for every individual with their own different essence. Many times the right to judicial review and judicial activism act as an aid for the weaker sphere of Indian society in protecting their rights by forming a bridge between applicable laws made by legislation and by making public interest litigation a source to reach out to apex court for the grief of distraction of their fundamental rights.

Cases like ADM Jabalpur v. Shukla, is a signified witness for the huge change in judicial approach after emergency. Cases of Bandhua Mukti Morcha and Mukesh Advani v. State of Madhya Pradesh were directed towards bonded labour. In case of National Workers Union v. P.R. Rama Krishnan, Court asserted that law should adopt itself with changing society, and its role is dynamic in social transformation process. In M. C. Mehta v. Union of India, apex court observed that when any law does not fit in current scenario, it is the duty of court to evolve a new law.

There is a need to understand the positive perspective that this exercise of authority of the judiciary is not for vain glory but it is in discharge of its constitutional obligation or otherwise the judiciary will become crippled which in turn ruin democracy. There are numerous jurist and philosophers of legal world has shared their views over a unique ideology and created a pathway to understand its activist approach.
